CHANGES TO THE COMPOSITION OF THE BOARD

The Board of Directors (the “**Board**”) of Vibrant Group Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) wishes to announce that pursuant to Rule 210(5)(d)(iv) of the Listing Rules of the Singapore Exchange Securities Trading Limited (“**SGX-ST**”) (“**Listing Manual**”), Mr Sebastian Tan Cher Liang (“**Mr Tan**”), Non-Executive and Independent Chairman, and Mr Derek Loh Eu Tse (“**Mr Loh**”), Non-Executive and Independent Director, who had each exceeded the aggregate period of more than nine (9) years as a Director of the Company, would not be considered independent after the conclusion of the Company’s Annual General Meeting (“**AGM**”) held on 30 August 2024.

Accordingly, Mr Tan will be re-designated as Non-Executive and Non-Independent Chairman, and Mr Loh will be re-designated as Non-Executive and Non-Independent Director of the Company.
